Digital Media: Conditions of Use September 2015

Dear Parents and Carers,

Attached to this letter is a consent form regarding the use of your child's 'digital media' at Abbotskerswell Primary School. The term 'digital media' includes photographs, video and sound. This consent form will last for the entire time that your child attends this school and also once they have left.

In an ever changing technological world the school would like to stay current with its online presence. We have a Facebook page, Twitter account and Google+ page which we already use to post updates, reminders and links to new information that has been added to the school website. The school has its own Flickr and Vimeo account which we would like to use in conjunction with our school website to share the learning and achievements of our pupils. Using digital media accounts like Flickr and Vimeo will allow us to keep photos, videos and sound clips available for many years to come.

All school online accounts and profiles are monitored and have as many restrictions as possible put in place. If at anytime you see any problems when viewing digital media on our online accounts please contact the school as soon as possible. You can do this immediately by using the relevant contact form on the **contacts page** of the school website.

Please read the following 'conditions of use' and then complete the attached consent form and return to school as soon as possible. Thank you.

## Conditions of use regarding digital media at Abbotskerswell Primary School:

- We will not use your child's digital media for any purpose if it would prejudice the interests of your child.
- We will only use digital media of pupils who are suitably dressed in a school uniform or PE kit and will avoid taking digital media of pupils in swimming costumes, except in appropriate circumstances, for example, a swimming event.
- We will only use the minimum amount of personal information about your child on our school website or publications, such as their first name, school name and possibly year group. We will avoid using full names on most occasions; exceptions may include newspapers, Abbtalk and television companies who may request surnames or when publishing recordings of school plays within school. We will not reveal personal e-mail addresses, home telephone numbers or home addresses.
- We will keep your child's personal information secure.
- We will keep your child's digital media secure within school.
- We will do our best to ensure all digital media is safe on our online accounts. For each online account we will disable as many features as we possibly can, for example, leaving comments, options for downloading or sharing digital media. Please note that each online account provide different levels of restrictions.
- We will not post children's names on any of our online social media or digital media accounts (only directly on our school website where appropriate).
- We will not post digital media directly onto social media accounts such as Facebook, Twitter and Google+, but we will post links to view them via these social media accounts.
- We will not use your child's digital media for any reason other than those stated, unless we have a legal obligation or power, or have received consent from you.
- We will have the most up to date 'conditions of use' available to read on our school website. This will allow you to keep up to date with any changes we make in the future and for your own reference.
